Multiple licenses of Basic and Reports Edition are assigned to the same postal address as the first license.

2) **Copyright:** All Veit Christoph GmbH software is protected by copyright. Duplication is only permitted for personal use and solely for backup and archiving purposes. All copyrights are in the possession of the licensor. Reverse engineering, decompiling and disassembly of the software are not permitted. The transfer of the software to a third party is prohibited. If there is an infringement of this condition then the licensee will honour a contract penalty equal to 20x the program price according to the current price list. The license is purchased without time limitation and is non-transferable. The software remains the property of the licensor till the time the full payment of the license fee is paid.

3) **Guarantee/liabilities:** The warranty period is six months. Software under this agreement is provided to the licensee as is. The licensor accepts no liabilities, be it explicit or implicit, for damage or consequential damage which results from the use of the program.
